



**BASALT TOWN COUNCIL  
MEETING MINUTES – APRIL 24, 2018**

**Basalt is an inclusive, sustainable, mountain community that boasts both historic charm and progressive vision. It is an engaging place to live, work and play while offering an abundance of creative, professional, educational and recreational outlets.**

**1. CALL TO ORDER AND ROLL CALL (Mayor and Clerk)**

Mayor Jacque Whitsitt called the meeting to order at approximately 6:00 PM on Tuesday, April 10, 2018. Council members present were Jennifer Riffle, Gary Tennenbaum, Bernie Grauer, Katie Schwoerer and Mark Kittle. Council member Auden Schendler was absent.

Bennett Bramson thanked Council for the improvements made to the sound system which improved the sound in the council chambers for the audience members.

Mayor Whitsitt thanked staff and the election judges for their recent work on the election process.

**4. MAYOR AND COUNCIL REPORTS/COMMENTS**

Gary Tennenbaum thanked all the candidates who ran for council seats this election and appreciated the positivity of the campaigns and hoped that would continue.

Mayor Whitsitt thanked staff and the election judges for their work on the election which beings months in advance.

Jacque said she served as a volunteer with representatives from Eagle and Pitkin counties to appoint three (3) Library Board members. Jacque said it was a difficult situation given every applicants' background and talents.

**5. MANAGER'S REPORT**

Town Manager Ryan Mahoney said staff (Ryan, Susan Philp and Sara Nadolny) had met recently with the US Forest Service to file an objection over the Frying Pan tree removal project. The USFS indicated they could not limit the times of day that the trucks would pass through the Town, but they could limit the term of the contract.

The bid period has been closed for the Town Attorney position. Three applicants have submitted. Staff will work with Council to set an interview schedule for the applicants.

Four Seasons who does a lot of our gardening and lawn mowing will begin a week early to clean up flower beds and lawns.

We are in the process of hiring season folks for landscaping and pool.

Big rains on Saturday caused some minor erosion to the new River Park. Public Works has identified the problem and will work to correct the issue.

Our Students of the Month will now be notified of their free season pool pass via a note tucked into their certificate folder that will indicate that they won't receive an actual paper pass, but their name will be on file at the pool. They simply need to check in at the pool office when they want to use the pool.

Planner Watkins Fulk-Gray and Basalt Sign Committee Representative Lynne Mace discussed this item with Council.

Assistant Planning Director James Lindt and Construction Manager Dana Dalla Betta, Roaring Fork Valley Habitat for Humanity President Scott Gilbert, Pitkin County Assistant Manager Phyllis Mattice, and Attorney Lucas Peck were present to discuss this project with Council.

Mayor Whitsitt opened the public hearing at 7:12 PM. There were no public comments and the hearing was closed.


