

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF BASALT,
COLORADO, APPROVING AMENDMENTS TO BASALT MUNICIPAL CODE
SECTION 6-14, TEMPORARY VENDOR USE OF PUBLIC PROPERTY AND
RIGHT-OF-WAY**

**Ordinance No. 12
Series of 2014**

RECITALS

1. The Town of Basalt ("Town") acting by and through its Town Council has the power to amend the Municipal Code of the Town of Basalt ("Town Code") pursuant to state statutes, Section 1.3, Home Rule Charter, and Section 1-58, Town Code, and all such amendments shall become a part of the Town Code.

2. At a public meeting on April 8, 2014, the Town Council approved this Ordinance on first reading and scheduled a public hearing and second reading for this Ordinance for April 22, 2014, for a meeting beginning no earlier than 6:00 pm at the Basalt Town Hall, 101 Midland Avenue, Basalt, Colorado.

3. At the April 22, 2014, public hearing, the Town Council heard evidence and testimony as offered by the Town Staff, and members of the public.

4. The Basalt Town Council finds, determines and concludes that the proposed code amendments are necessary to protect the health, safety, welfare and quality of life for the citizens of the Town.

5. The Town Council finds and determines it is in the best interests of the Town to amend the Town Code as provided herein.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of Basalt, Colorado, as follows:

1. Town Code Section 16-4(b), is hereby amended as shown in **Exhibit A.**

2. If any part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance and the Town Council hereby declares it would have passed this Ordinance and each part, section, subsection, sentence, clause or phrase thereof regardless of the fact that any one or more

parts, sections, subsections, sentences, clauses or phrases be declared invalid.


3. This Ordinance shall be effective 14 days after final publication of the Ordinance in accordance with the Town Home Rule Charter.

READ ON SECOND READING AND ADOPTED, by a vote of 6 to 0, on April 22, 2014.



Exhibit A

Changes to Section 6-14, Temporary Vendor Use of Public Property and Right-of-Way.

Amend Section 6-14(b), Temporary Vendor Use of Public Property and Right-of-Way as follows:

(b) Temporary vendors using public property or public rights-of-way shall be limited to use up to twelve (12) times days per year. ~~Special events, such as River Days, are subject to exemption from this time limitation by the Town Manager.~~ Exceptions from the above limitation may be granted by the Town Council upon approval of a resolution.
