

**TOWN OF BASALT
ORDINANCE NO. 38
SERIES OF 2014**

AN ORDINANCE APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS, AND FOR THE PURPOSES SET FORTH IN BELOW, FOR THE TOWN OF BASALT, COLORADO, FOR THE 2015 BUDGET YEAR.

WHEREAS, the Town Council for the Town of Basalt, Colorado, adopted the annual budget in accordance with the Local Government Budget Law; and

WHEREAS, the Town Council has made provision therein for revenues and reserves in an amount equal to or greater than the total proposed expenditures as set forth in said budget; and

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues and reserves provided in the budget to and for the purposes described below, so as not to impair the operations of the Town of Basalt; and

WHEREAS, at a public meeting held on November 18, 2014 the Town Council considered approval of this Ordinance on first reading and scheduled a public hearing and second reading for the ordinance for December 09, 2014, for a meeting beginning no earlier than 6:00 pm at the Basalt Town Hall, 101 Midland Avenue, Basalt, Colorado; and

WHEREAS, at a public hearing and second reading on December 09, 2014, the Town Council heard evidence and testimony as offered by the Town Staff and members of the public.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BASALT, COLORADO: That the amounts set forth below are hereby appropriated from the revenue and reserve of each fund, to each fund, for purposes stated:




READ ON SECOND READING AND ADOPTED, by a vote of 7 to 0 on December 09, 2014.
