RECITALS

1. The Town of Basalt owns and maintains all streets related to the contract within the scope of work for the 2018 Street improvements project.
2. The Town of Basalt Public Works Director, Assistant Public Works Director, and SGM Engineering determined the roads within the contract are in need of different repairs and resurfacing treatments.
3. The Town budgeted funds for pavement repair and maintenance.
4. A set of electronic bid documents were completed by SGM Engineering.
5. The Town issued a Request for Bids for construction services to complete the 2018 Road Maintenance Project pursuant to the Town of Basalt Procurement Policy and Procedures and the Town received four bids for the Project.
6. The Town's Engineer, SGM, recommended that the project be awarded to the low bidder, Grand River Construction from Glenwood Springs, Colorado.

NOW, THEREFORE, BE IT RESOLVED by the Basalt Town Council of Basalt, Colorado, as follows:

Based on the evidence, testimony, exhibits, and comments from the public and Town Staff, the Basalt Town Council hereby:

1. Approves the 2018 Road Maintenance Project list and directs Staff to enter into the contract with Grand River Construction for all of the included projects.
2. Recognizes that the total accepted project list including the 2018 Road Maintenance Projects for a total of \$662,984.

STANDARD AGREEMENT

THIS AGREEMENT, made this 2nd day of May, 2018, by and between Town of Basalt, hereinafter called "OWNER", and Grand River Construction Co., doing business as (a Corporation) (an Individual) or (a Partnership), hereinafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The CONTRACTOR will commence and complete the construction of **Town of Basalt Road Maintenance 2018**.
2. The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other service necessary for the construction and completion of the WORK described herein.
3. The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS within **30 calendar days** after the date of the NOTICE TO PROCEED and will substantially complete the same by **October 15, 2018** unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
4. The Contractor agrees to perform all of the Work described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum of \$ 529,012.24 Dollars, as shown on the BID SCHEDULE.


