

**TOWN OF BASALT
ORDINANCE NO. 22
SERIES OF 2009**

**AN ORDINANCE LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2009,
TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF BASALT,
COLORADO, FOR THE 2010 BUDGET YEAR.**

WHEREAS, the Town Council of the Town of Basalt, has adopted the annual budget in accordance with the Local Government Budget law, on December 08, 2009; and

WHEREAS, the amount of money necessary to balance the budget for the general operating purposes from property tax revenue is \$586,180, and;

WHEREAS, the Town of Basalt finds that it is required to temporarily lower the general operating mill levy to render a refund for \$12,696, and;

WHEREAS, the amount of money necessary to balance the budget for voter approved bonds and interest is \$300,000, and;

WHEREAS, the 2009 valuation for assessment for the Town of Basalt as certified by the County Assessors is:

Eagle	\$155,854,810
Pitkin	\$ 72,919,940

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Basalt, Colorado, that:

Section 1. That for the purpose of meeting all general operating expenses of the Town of Basalt during the 2010 budget year, there is hereby levied a tax of 2.562 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Basalt for the year 2009.


Section 2. That for the purpose of meeting all payments for bonds and interest of the Town of Basalt during the 2010 budget year, there is hereby levied a tax of 1.311 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Basalt for the year 2009.

Section 3. That Pamela K. Schilling, Town Clerk, is hereby authorized and directed to immediately certify to the County Commissioners of Eagle and Pitkin Counties, Colorado, the mill levies set for the Town of Basalt as hereinabove determined and set.



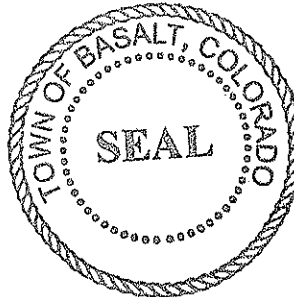
READ ON SECOND READING AND ADOPTED, by a vote of 5 to 0 this 8th day of December, 2009.
