

**TOWN OF BASALT
ORDINANCE NO. 25
SERIES OF 2020**

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF BASALT, COLORADO, APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS, AND FOR THE PURPOSES SET FORTH BELOW, FOR THE TOWN OF BASALT, COLORADO, FOR THE 2021 BUDGET YEAR.

WHEREAS, the Town Council for the Town of Basalt, Colorado, adopted the annual budget in accordance with the Local Government Budget Law; and

WHEREAS, the Town Council has made provision therein for revenues and reserves in an amount equal to or greater than the total proposed expenditures as set forth in said budget; and

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues and reserves provided in the budget to and for the purposes described below, so as not to impair the operations of the Town of Basalt; and

WHEREAS, at a public meeting held on November 24, 2020 the Town Council considered approval of this Ordinance on first reading and scheduled a public hearing and second reading for the ordinance for December 8, 2020, for a meeting beginning no earlier than 6:00 pm virtually at the Basalt Town Hall, 101 Midland Avenue, Basalt, Colorado; and

WHEREAS, at a public hearing and second reading on December 8, 2020, the Town Council heard evidence and testimony as offered by the Town Staff and members of the public.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BASALT, COLORADO:

1. The foregoing recitals are incorporated herein and adopted as findings by the Town Council.
2. Any and all year-end balances for budget year 2020 are hereby carried forward to their respective funds for budget year 2021.

3. That the amounts set forth below are hereby appropriated from the revenue and reserve of each fund, to each fund, for purposes stated:

General Fund

If any part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance and the Town Council hereby declares it would have passed this Ordinance and each part, section, subsection, sentence, clause or phrase thereof regardless of the fact that any one or more parts, sections, subsections, sentences, clauses or phrases be declared invalid.

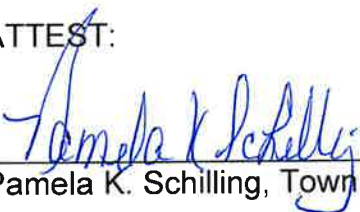
